Nurseries, schools and childminders offering early years education to 3 and 4 year olds can claim up to an extra £300 funding through the EYPP. This funding can be used by the childcare setting to enhance the education provided to your child through additional training for staff or developing the expertise of staff working in specialised areas of children's development.

The funding will be paid to the childcare setting if you are in receipt of one of the benefits listed or if you are the parent or carer of a child/ren who has previously been in Local Authority care.
